

By now, it is many years since your prime. The head is not as sharp as it was, so for





go away – you will get a proper scolding, but that too is a kind of attention.



You have always had a temper and have often gotten into fights. One time it also got out in the media. Once you also punched a client who pissed you off.



#### Relations

The players choose relations between the characters that are among the reasons why the characters don't like each others. Place them openly at the middle of the table. When the players have read their roles they each choose <u>one</u> relation for each of the other two main characters – thus each pair of characters have two relations between them. The choice is not a secret and the relation can be explained. If it says "the one" and "the other" it has to be decided who is whom – this is decided by the player who chose the relation.

#### Supporting characters

The following are an array of supporting characters. Lucy is your role as gamemaster. The others can be cut out and be available to both you and the players. The supporting characters are suggestions – the players are more than welcome to come up with others.



#### Lucy Ferrera

Your primary role as gamemaster. Lucy appears as a young, devilishly beautiful woman. On the surface she appears as friendly and responsive to the characters. But actually she uses their wishes, desires and hatred to bring forth the worst in them.

Behind the fascade, she has a devil face that is hidden to the characters until the epilogue.

Lucy is the supporting character you as gamemaster use for the scenes in Hell. Her purpose is to help the players start the courtroom scenes and to sow discord between the characters in the Hell-scenes.



#### Bob Beeltz

Multibillionaire Bob Beeltz tortured, killed and ate seven teenage girls in the 1980s, but the charges were acquitted thanks to Jack Marwood – who knew very well that Bob was guilty.

As a person, Bob appears as complacent and greasy.



#### Francis Quade Sr.

Francis Quade Sr. is a serious and stern man, who more than anything in the world cares about the family name. He often helps his son "Junior" get out of trouble.



#### Vanessa Quade

Married to Francis Quade Sr. and mother of Francis Quade Jr.. Is one of the famous house wives of New York. Known for her diva-attitude and typically seen with a drink in her hand.



#### George Rasmussen

George is a lawyer at Marwood, Quade & Wriedt. He often makes jokes at the expence of others and enjoys, among other things, to make fun of minorities. He is convinced that the women at work want him, in spite all their rejections.



#### **Beth Jones**

Beth is a secretary at Marwood, Quade & Wriedt. A kind and open person, exuberant and extroverted. She knows everything about everybody and gladly shares confidential information.



#### Tom Walker

Tom is under charges of violent robbery and has several smaller sentences behind him. He is hot tempered and not very intelligent.



#### Kate Miller-Worthington

Kate is a rich client of great importance to Marwood, Quade & Wriedt. On the surface she is the owner of a high fashion chain with several shops in New York and the rest of the country. But she also controls a big portion of New York's sale of cocaine.

In spite of a polite fascade, there is a toughness behind and her icy gaze can give you the chills.



#### Terrence Wriedt

Terrence Wriedt is partner at Marwood, Quade & Wriedt. On the surface a kind and jovial man, but he also has a temper. Many witnesses have seen him punch a colleague.
